# **Statehouse Happenings**

A new year has begun, and legislators have been sworn into office. The opening session of the 136th General Assembly was Monday, January 6. But before we delve into what might happen with that one, we need to wrap up the 135th General Assembly and see what happened during its final weeks. Here is the committee action in December.

#### December 2 – 6

The first bill scheduled for a hearing on Tuesday morning was Senate Bill 208 in the House Primary and Secondary Education Committee. It was the 3rd hearing for the bill and there was no testimony provided. The bill would require school districts to include an exception for military children in open enrollment policies. There are multiple other portions to the bill but none of them pertain to our military. It was introduced by Senator **Kristina D. Roegner** (District 27).

Tuesday afternoon the House Transportation Committee had eight bills scheduled -three were veteran related bills. They were HB 674, HB 679, and HB 691. HB 691 had its first hearing. The bill's primary sponsors, Representatives **Jay Edwards** (District 94) and **Adam Holmes** (District 97) provided written testimony as did one citizen. A motion was made to favorably report the bill out of committee and a vote of 13 to 0 followed. The bill will designate a portion of State Route 13 in Athens County as the "Marshal Teddy Ray Holcomb Memorial Highway".

Next was House Bill 679 for its first hearing. The bill was introduced by Representative **Angela N. King** (District 84) in October and will designate a portion of State Route 47 in Darke County as the "PFC John Wayne Richard Memorial Highway". King provided sponsor testimony followed by a vote to favorably pass the bill. The vote was 13 to 0.

Representative **Sara P. Carruthers** (District 47) provided sponsor testimony on the bill she introduced in October 2024. HB 674 will designate a portion of State

Route 129 in Butler County as the "Sgt. Anthony Kress Vinnedge Memorial Highway". It too passed favorably out of committee with a 13 to 0 vote.

Later that afternoon, the House State and Local Government Committee heard proponent testimony for Senate Bill 62. Senators **Bill Reineke** (District 26) and **Andrew O. Brenner** (District 19) introduced the bill in February 2023. The bill would designate October 4

## **OHIO CONSTITUTION**

### ARTICLE I, BILL OF RIGHTS

# SECTION #20 ~ POWERS RESERVED TO THE PEOPLE

Effective: 1851

This enumeration of rights shall not be construed to impair or deny others retained by the people; and all powers, not herein delegated, remain with the people.

#### SECTION #21 ~ PRESERVATION OF THE FREEDOM TO CHOOSE HEALTH CARE AND HEALTH CARE COVERAGE

#### Effective: 2011

(A) No federal, state, or local law or rule shall compel, directly or indirectly, any person, employer, or health care provider to participate in a health care system.

(B) No federal, state, or local law or rule shall prohibit the purchase or sale of health care or health insurance.

(C) No federal, state, or local law or rule shall impose a penalty or fine for the sale or purchase of health care or health insurance.

(D) This section does not affect laws or rules in effect as of March 19, 2010; affect which services a health care provider or hospital is required to perform or provide; affect terms and conditions of government employment; or affect any laws calculated to deter fraud or punish wrongdoing in the health care industry.

(E) As used in this Section,

(1) "Compel" includes the levying of penalties or fines.

(2) "Health care system" means any public or private entity or program whose function or purpose includes the management of, processing of, enrollment of individuals for, or payment for, in full or in part, health care services, health care data, or health care information for its participants.

(3) "Penalty or fine" means any civil or criminal penalty or fine, tax, salary or wage withholding or surcharge or any named fee established by law or rule by a government established, created, or controlled agency that is used to punish or discourage the exercise of rights protected under this section.

### Happenings, from Page One

Rutherford B. Hayes Day. Testimony was heard from members of the Rutherford Hayes Heritage and saw written testimony from Rutherford B. Hayes Presidential Library and Museum, and Ohio History Connection.

Wednesday morning the House Insurance Committee held the third hearing for Amended Senate Bill 63. This bill, which would require a plaintiff in a tort action alleging an asbestos claim to file specified disclosures was introduced in February 2023 by Senator George F. Lang (District 4) and since that time received amendments. Before hearing opponent testimony from a representative for The Ohio Association for Justice more changes were brought forth -enough to make the bill Substitute Senate Bill 63. The changes addressed many of the issues and concerns from opponents of the bill such as the Ohio American Legion, Ohio Veterans of Foreign Wars, Ohio Association of Professional Firefighters, and The Ohio Association for Justice. The substitute bill was accepted by the committee without objection.

Also, that morning the House Homestead Security Committee met. Four veteran related bills were scheduled for hearings. They would create special license plates. First was HB 209 and proponent testimony was given by two members of the Ohio Society Daughters of the American Revolution. The bill was introduced in June 2023 by Representative **Rodney Creech** (District 40) and had three previous hearings. The bill will create the "Ohio Society Daughters of the American Revolution" license plate. Following the testimony the bill was favorably passed out of committee with a 11 to 1 vote.

House bill 625 was next and testimony was given by Representative **Tex Fischer** (bill sponsor **Al**

**Cutrona** had been appointed to the Ohio senate to fill the seat vacated by then Senator **Michael A. Rulli** when he was appointed to fill the congressional seat vacated by then Congressman Bill Johnson). The bill will create the "American Legion Auxiliary" license plate and revise the requirements for the issuance of the "American Legion" license

plate. This was the bill's first hearing.

There was no testimony for the second hearing for HB 423. The bill introduced in February 2024 by

Representative **Joseph A. Miller III** (District 53) will create the "Blue Star Banner" license plate. It received a unanimous vote to favorably pass the bill out of committee.

The committee heard testimony from two representatives of Save A Warrior, Inc. It was the second hearing for HB 483, a bill introduced by Representative **Kevin D. Miller** (District 69) in April 2024. The bill will create the "Save a Warrior" license plate. Committee members voted unanimously to favorably pass the bill out of committee.

In the Senate Veterans and Public Safety Committee two bills received their second hearing. First was SB 281, a bill that will create a poster containing information on benefits and services for veterans that Ohio employers may request and display on their premises. It was introduced in May 2024 by Senators **Hearcel F. Craig** (District 15) and **Terry Johnson** (District 14). Testimony was provided by three members of the United Steel Workers Union who were also veterans.

Proponent testimony for House Concurrent Resolution 8 was next. Only written testimony was provided from representatives of Central Ohio Defense Group and Ohio Chamber of Commerce. HCR 8 was introduced by Representative **Brian E. Lampton** (District 70) in June 2023. It will urge the federal government to select Ohio for the permanent headquarters of the United States Space Command.

#### December 9 – 13

In the House Insurance Committee Tuesday morning a fourth hearing for Sub SB 63 was held. There was no testimony, and a unanimous vote was cast to favorably pass the bill out of committee.

SB 62 had its third hearing in the House State and Local Government Committee. An amendment was agreed to that added to the bill the designations of 10 more special days, weeks, or months including making September 11 "9/11 Remembrance Day". The amended bill also makes the Walleye Ohio's official state fish and deals with Alzheimer's disease and dementia awareness and sudden unexpected death in epilepsy. The amended bill was then favorably passed out of committee with a 15 to 0 vote.

A fourth hearing was held for HB 274. The bill will authorize an enhanced property tax homestead exemption for certain long-term homeowners. Written testimony was supplied on behalf of the County Commissioners Association of Ohio but there was no in person testimony. HB 274 would add an

additional enhanced homestead tax exemption for those who have lived in their homes for twenty years or more and who qualify under the current law. It was introduced by Representatives **Adam Mathews** (District 56) and **Richard Dell'Aquila** (District 15) in September 2023. Following one accepted amendment and one failed amendment the bill was favorably passed with a unanimous vote.

There was no in person testimony on SB 257 during the House Economic and Workforce Committee, but there was written testimony submitted on behalf of Ohio REALTORS and Ohio Credit Union League in support of the bill. SB 257 will make active-duty members of the uniformed services eligible to participate in the homeownership savings linked deposit program and regarding Ohio National Guard Scholarship Program repayment interest. It was introduced by Senators **Brian M. Chavez** (District 30) and Johnson (District 14) in May 2024. After the committee accepted an amendment, they voted unanimously to favorably pass the bill out of committee.

Senator Roegner's bill to require a military exception in an open enrollment policy had it's fourth hearing before the House Primary and Secondary Education Committee on Wednesday. An amendment to Sub SB 208 was accepted by the committee. The amendment contained numerous items that did not pertain to the veteran related portion except for one item. It was added that military children to continue to attend that district and receive transportation services for the remainder of the school year if the student's parent is discharged or released from active duty and that after the conclusion of that school year, that student is not eligible to attend that district under the bill, as long as the student does not have a parent on active duty. The bill was then favorably passed out of committee with a unanimous vote of the committee.

In the Senate Veteran and Safety Committee, SB 281 and HCR 8 both had their third hearing. Neither had any testimony and both were favorably passed out of committee with unanimous votes.

#### December 16 – 20

On Tuesday the House Transportation Committee had written testimony from Senator **Sandra O'Brien** (District 32) for her bill, SB 45. As introduced in February 2023 it would designate the bridge spanning the Mahoning River (part of State Route 534) in Newton Falls as "Veterans Memorial Bridge". However, when the committee favorably passed the bill, the language had been removed and put into House Bill 81 along with many other bills making it an omnibus bill. They were bills that the committee had previously passed and incorporating them all into one bill would save valuable time in sessions. Ater removing the memorial bridge language from Sub SB 45, the following bills were put into it -HB 28, HB 652, HB 664, HB 673, HB 674, HB 679, and HB 691 all of which would designate portions of highways as memorial highways in honor of Ohio veterans. Also added was HB 698 which will create the Dolly Parton's Imagination Library license plate and five other bills naming memorial highways in honor of notable Ohio citizens.

#### The Final Days of the 135th General Assembly

During a lame duck session, it becomes very hard to track bills and determine if they were signed into law or if they died. Several bills might be consolidated into a single bill or amended into other bills. Here are a few examples of what OLR was able to track down.

House Bill 231 the bill to establish the 9-8-8 suicide prevention, mental health telephone line was amended into HB 211, known as the Free to Speak Act. The governor signed that bill on January 8.

House Bill 365 was introduced, designating three different memorial highways. It was amended into House Bill 380 which originally designated one memorial highway. House Bill 380 was then amended into House Bill 81. House Bill 458 designating a memorial bridge and a memorial viaduct was also amended into House Bill 81. House bill 81 started as a bill to designate a memorial highway in honor of a Carrol County Sheriff finished but finished designating 57 memorial highways or bridges. Governor DeWine signed it into law on December 19.

House Bill 45 was introduced to designate a bridge in Trumble County the "Veteran's Memorial Bridge." That language was removed and amended into House Bill 81. In its place were 12 other bills. Unfortunately, OLR has been unable to track HB 45 after it was passed out of the House Transportation Committee.

OLR followed 65 bills in the House and 33 bills in the Senate during the 135th General Assembly. Not all of them made it across the finish line. Those that made it and were signed by the governor will become part of the Ohio Revised Code. Those that did not have died. They will need to be introduced again during the 136th General Assembly as a new bill if they are to successfully become law.


